



## **Horizon Europe CLIMABOROUGH**

### **CALL FOR TENDERS**

#### **TENDER PROCEDURE FOR THE SELECTION OF AN INDIVIDUAL CONSULTANT TO ASSIST IN SCIENTIFIC COORDINATION AND DISSEMINATION ACTIVITIES RELATED TO THE HORIZON EUROPE CLIMABOROUGH PROJECT (CUP B15C22028000006)**

##### **I. BACKGROUND INFORMATION**

ANCI Toscana is the coordinator of the Horizon Europe CLIMABOROUGH project (IA), approved by the European Commission under Grant Agreement number: 101096464 – CLIMABOROUGH - HORIZON-MISS-2021-CIT-02, entitled “Building Green and Climate Neutral City-Hubs” (Project 101096464)

CLIMABOROUGH has the ambition to bridge the gap between design and implementation of urban innovations, particularly in the face of climatic change and its consequential needs for adaptation and mitigation, by investigating whether and to which extent urban planning can and should be transformed in its current approach to spatial design and spreading of human activities, in order to break the silos that impede or slow down the transition of European Cities towards a new ecological and digital order.

The project has a duration of 48 months, starting from 1st January 2023. It brings together a wide partnership of 26 partners including universities, grassroots organizations, public bodies and businesses across Europe.

##### **ABOUT THE CLIMABOROUGH PROJECT**

CLIMABOROUGH is an Innovation project designed to field test the ClimHub, Climate Sandbox and Climate Service concepts within 12 European Cities engaged in their ecological and digital transition. The project aims to enhance traditional urban and spatial planning approaches through data and knowledge based decision making (including a possible new role for GIS - Geographic Information Systems), including climate services co-production for transitions, cross-city and cross-country pilot co-creation as well as the tactical use of public procurement of innovative solutions. The goal is not just to enhance an open set of tools leveraging climate transition in cities, but also to boost the exchange of experimental good practices, experiences and lessons learnt in this field, to help cities meet climate neutrality by 2050. This will be achieved by the following expected results: (A) building ClimHubs of Cities and solution providers to work on experimentations in real conditions, (B) harnessing the collective intelligence of local stakeholders for collaborative solution development, (C) defining Climate Services as a model strategy to use data and visualisation tools for climate transition, (D) field testing the Climate Sandbox concept as a way to prioritise and facilitate transformation of successfully deployed prototypes into established solutions for climate adaptation and mitigation in cities, and (E)



monitoring and assessing the progress in achieving those goals and in implementing a climate neutrality planning scheme. Based on the lessons learnt and successful concept of the H2020 Designscapes CSA, CLIMABOROUGH has the ambition to bridge the gap between design and implementation of urban innovations, particularly in the domain of climate change adaptation and mitigation.

CLIMABOROUGH defines and aims to test three innovative concepts:

1. The “Climate Sandbox”, facilitating under a legal and/or administrative point of view, the diffusion of technologically and societally innovative solutions, whenever they can document a strong capacity of carbon dioxide recapturing or climate change adaptation, much in the same way as in the past, urban transformation initiatives were facilitated by the regulator, whenever they promised to bring high socio-economic benefits;
2. The “ClimHub”, which is more than a Lighthouse pilot, in the sense that it promotes and actively works for a faster and more widespread diffusion of sustainable innovations against the climatic threats, leveraging on the evidence-based learning generated by co-creation dynamics seeing startup companies and solution providers involved on a peer basis with local public sector authorities in innovative replication methods;
3. The “Climate Service”, consisting in the transformation of climate-related data - together with other relevant information - into customised products such as projections, forecasts, information, trends, economic analyses, assessments, counselling on best practices, development and evaluation of solutions and any other service in relation to climate that may be of use for the society at large<sup>1</sup>.

These three concepts will be tested within a significant number of European cities, characterised by a wide variety in size, interests and geographical location.

## **CORE PROJECT OBJECTIVES**

CLIMABOROUGH has the ambition to bridge the gap between design and implementation of urban innovations, particularly in the face of climatic change and its consequential needs for adaptation and mitigation. The European Commission stressed this important point in its first official document of the 100 Climate Neutral and Smart Cities Mission: “The main obstacle to climate transition is not a lack of climate-friendly and smart technologies, but the capacity to implement them.” It will do so by addressing the following specific objectives:

Key objective 1. Build, launch and manage a mission-oriented and hub-based programme to support a diverse range of urban areas across Europe in co-creating innovation to reduce emissions.

Key objective 2. Establish and develop a scheme to support cities to define a business model with startups and established companies to improve the scalability of climate friendly solutions.

Key objective 3. Support the ongoing formation of a community of cities and related stakeholders (citizens, companies, SMEs, associations...) to define a participatory model and ensure uptake endures and expands.

Key objective 4. Define and build a climate neutrality monitoring tool by integrating existing solutions.



CLIMABOROUGH will launch a public procurement process which will drive to select various climate related services/products, provided by startups, useful for deployment in cities. Those services will create and provide data that will be collected by the platform and they will be made available for the construction and the deployment of the Climate Neutrality monitoring tool. The project set aside 3 million Euro for the public procurement, expecting at least 2 winners per call with distinct proposals, distributing the risk of failure across more examples. Expected results of the public procurement process are as follows:

- 12 open market consultations.
- 12 public procurement of innovation calls.
- 24 awarded proposals of urban service innovation.
- 1 dedicated private investment fund with 20 applications.

### MAIN PROJECT OUTCOMES

- 1) Co-creation of solutions in cities towards climate neutrality with stakeholders
- 2) Connection between startups/SMEs and cities for climate friendly services via public procurement
- 3) Deployment of climate services with living lab techniques
- 4) Definition of a Climate Neutrality monitoring tool (including monitoring climate transition of cities integrated in urban planning) and its evaluation framework
- 5) Mentoring services to improve replication between cities.

## II. EXTENT

The selected applicant will be in charge of supporting ANCI Toscana in the performance of **scientific coordination and dissemination of results activities of the project**. In particular, she/he will supervise the co-creation in Cities, the definition of climate services, the living lab techniques in deployment of services, the collection of data and the definition of the IT platform and the dissemination strategy (including its deployment).

In particular, the selected applicant will carry out the following tasks:

1. Leading the whole project plan from a scientific point of view
2. Organizing and leading Project Board meetings
3. Participation in the alignment meetings for the development of the IT infrastructure
4. Organizing and leading the dissemination strategy meetings and then lead the strategy itself
5. Support to the definition of most important deliverables of the project, namely:
  - D6.1 Dissemination and communication plan
  - D6.2 Dissemination and communication update (3 versions)
  - D6.3 Exploitation and IPR plan and strategy
6. Strategic support for platform construction (WP2)
7. Strategic support for the definition of the city hubs (WP3)
8. Living Labs deployment (WP5)
9. The exploitation and IPR strategy (WP6)



### III. GENERAL REQUIREMENTS

Subjects possessing the following requirements can apply:

- a) Being a VAT holder;
- b) Enjoyment of civil and political rights in the States of origin and residence;
- c) Age: not less than 18 years old and not more than 65 years old;
- d) Not having reported convictions and not having pending criminal proceedings that prevent, under the applicable provisions in force, the establishment of the employment relationship with the Public Administration;
- e) Proven professional experience with at least 10 years of experience in the management and / or scientific coordination of EU funded projects.
- f) Proven professional experience of at least 5 years working with local public administrations;
- g) Excellent knowledge of written and oral English, proven by the publication of research reports or papers.
- h) Knowledge of another EU language, preferably French or German.

### IV. PRESENTATION OF THE TENDERS

The tenders must be presented as follows:

**- Participation request form enclosed to this tender with the following compulsory annexes:**

- Annex 1: A copy of a valid legible identification document
- Annex 2: Identification of the applicant: a cover letter with a brief presentation of the candidate and the selection of one of the three profiles
- Annex 3: Curriculum Vitae of the applicant in an Europass format.

The absence of any of the Annexes listed above shall entail the exclusion of the candidate from the evaluation phase.

### V. ELIGIBILITY AND EVALUATION



The applications are considered to be admissible and assessable if:

- received by the date and time indicated in this tender, and duly signed;
- submitted by a person in possession of the above listed requirements;
- submitted in all parts listed under the article IV.

The selection will take place through the evaluation of the curriculum and on the basis of the interview aimed at ascertaining the skills in the activities referred to in Article II.

The score attributed for the Curriculum Vitae will be maximum 50 points. The score attributed for the interview will be maximum 50 points.

All selection operations will be carried out by a special Commission appointed by the Director of ANCI Toscana.

The outcome of the preliminary investigation on the admissibility of the applications and the invitation to the interview will be communicated to the candidates through publication on the AncI Toscana website in the publication area of this notice on 10 January 2023, possibly extendable in relation to the number of questions received. This form of advertising constitutes notification for all legal purposes.

Failure to attend the interview will result in exclusion from this selection.

The interviews will take place on 11/12 January 2023 (the date may change and further dates may be added in relation to the number of applications received).

## **VI. SELECTION PROCESS**

For the purposes of evaluating the Curriculum vitae, the experiences declared in the participation request form will be taken into consideration. The Curriculum vitae will be used for a general overview of the candidate's experience and for any further study and better understanding of what is declared in the application form.

The following scores are assigned, (calculated in any case beyond the minimum requirements referred to in Article 3) according to the criteria indicated below:

### Curriculum vitae

- a) Number of EU funded projects worked on (completed and / or ongoing), with preference given to the Horizon 2020 programme and previous research and innovation framework programmes: 3 points per project, up to a maximum of 15
- b) Experience in dissemination and evaluation activities within EU projects, demonstrated by the number of EU funded projects worked on: 3 points per project, up to a maximum of 15



- c) Professional experience in European networks or associations of cities, with preference for topics such as open data, sustainability and climate change: 4 points for each year, up to a maximum of 12 points.
- d) Experience in setting up Living Lab pilots and / or using Living Lab techniques: 2 points for each year, up to a maximum of 8 points.

The interview will focus on the topics covered this selection to ascertain the general knowledge of the candidate in the context of the activities listed in the Art. 2 and its professional experience declared in the participation request form, in particular:

- a) Excellent communication skills, spirit of initiative teamwork ability, proven capacity to coordinate large working groups and foster collective achievement of shared goals.
- b) Excellent knowledge in writing blog posts in Italian and English;
- c) Excellent ability with social media.

## **VII. ASSIGNMENT OF THE SCORES AND RANKING**

For the purposes of the evaluation, the experiences declared in the participation request form will be taken into consideration.

A ranking will be drawn up exclusively for candidates who have obtained at least half of the maximum score foreseen for each of the thematic areas envisaged for the oral interview pursuant to Art. VI (a,b,c). In the event of a tie in total scores, priority will be given to the candidate with the highest score in the interview. In case of equal merit, the younger candidates will have priority.

In any case, Anci Toscana reserves the right not to proceed with any assignment.

## **VIII. VERIFICATION OF THE REQUIREMENTS AND FORMALISATION OF THE CONTRACT**

Once the selection has been completed, ANCI Toscana may proceed with the verification of the declarations made in the application for the person best placed in the ranking. This verification will take place through the acquisition of the related official documents or through the presentation by interested parties of the documents that cannot be ascertained directly by ANCI Toscana.

Following the positive outcome of this step, a contractual proposal will be sent in line with what is indicated in articles above.

The selected expert undertakes to not disclose or publish or in any case use data or news relating to the project without having obtained the prior written consent of the Director of ANCI Toscana and, in the case of publications, the prior approval of the related texts.

## **XI. CONFIDENTIALITY CLAUSE**

Despite the public execution of the project, part of the information exchanged for the development of the purpose of this contract between ANCI Toscana and the selected expert, may be confidential. On this basis, only the documents and other pieces of information provided explicitly with the statement “confidential” will be dealt with as such. The selected expert



ensures that respect its confidentiality and do not disseminate it, forward it to third parties or use it without prior written consent from the ANCI Toscana.

## **XII. PRIVACY PROTECTION CLAUSE**

Pursuant to the EU Regulation n. 679/2016, the processing of personal data of the applicants is finalized at the sole purpose of the professional assignment; the treatment of personal data will be within the limits necessary to pursue the aforementioned purpose, with suitable methods and tools to guarantee the security and confidentiality of applicants.
